Regulations – DISCUSSION DRAFTS (seeking public comment prior to filing with LRC)

The regulations provided in this section are **discussion draft documents only**, and released solely for early discussion and feedback. **There have been changes to the Practice Act Modernization bill HB 167 that are not reflected in these drafts, such as the change from mandatory inspections to a voluntary inspection program.** These drafts require further work by both the board and stakeholder groups before KBVE would even consider filing them. Finally, if these regulations are filed, they will undergo a public comment period and review by the General Assembly prior to becoming law, which can take at least six (6) months from the date of filing.
